

Georgia Planning Commission
2020 Meeting Dates and hearing publication deadlines

The Planning Commission is required to publish notice of the Commission’s public hearings in the local newspaper (*St. Albans Messenger*) at least 15 days prior to the meeting date. Staff determines if an application is complete before scheduling a hearing date. Applications must be signed by the owner of the property (or authorized representative), and be accompanied by the proper fee. Application forms are available at the town website, www.townofgeorgia.com/, or you can obtain paper copies at the Town Office.
